Contributions from corporations, labor unions, federal government contractors, national banks and foreign nationals without permanent residency status are prohibited.

Federal multi-candidate political action committees (PACs) may contribute \$5,000 per election. Contributions from corporations, labor organization treasury funds, foreign nationals, and federal government contractors are prohibited. Corporations and individuals are strictly prohibited from reimbursing another person for making a contribution to Jeff Doctor For Congress. Federal law requires us to use our best efforts to collect and report the name, mailing address, occupation, and name of employer for individuals whose contributions exceed \$200 in an election cycle. By making this contribution, you confirm that the following statements are true and accurate:

- You are a citizen or permanent resident in the United States.
